Resolved that the above mentioned candidate, excepting Smt. Sabitri Sen Gupta (Sl. No. 5) be appointed as Lecturer in their respective posts in the college on substantive basis on probationary period for one year w.e.f. their respective actual date of joining the posts in the scale of Rs. 700 - 1600/- plus usual allowances, benefits as admissible from time to time by the Govt. of West Bengal.

Further resolved that Principal/secretary be authorised to issue appointment letters immediately to the candidates mentioned above, excepting Smt. Sabitri Sen Gupta-Education with a stipulation to join within 15. 5. 1989, failing which the appointment letters be treated as cancelled. In case of Smt. Sabitri Sen Gupta Principal be authorised to move the case with the S.S.C. and seek necessary clarification and place it in the next G.G. meeting.
